TITLE II—LIMITING FEDERAL MANDATES

3 SEC. 201. LIMITATION ON FEDERAL MANDATES IMPOSED
4 ON ENTITIES SEEKING FEDERAL FUNDS.

5 (a) DEFINITION.—In this section, the term "agency"
6 means an establishment in the executive branch of the
7 Federal Government.

8 (b) LIMITATION.—The head of an agency may not 9 impose on an entity seeking Federal funding from the 10 agency a mandate to have in effect any of the following 11 policies:

(1) Policies relating to prioritizing hiring, training, and retaining employees comparable to policies
established in Executive Order 14305 (86 Fed. Reg.
34593; relating to diversity, equity, inclusion, and
accessibility in the Federal workforce).

17 (2) Policies for a workforce plan or a commit18 ment to include plans to hire, train, and retain a di19 verse workforce, including economically disadvan20 taged individuals.

21 (3) Policies on the provision of childcare for22 children of employees.

23 (4) Policies on the provision of wraparound24 services for the workforce, including adult care,

1	transportation services, housing assistance, and
2	emergency cash assistance.
3	(5) Policies on a community investment plan,
4	including affordable housing, housing vouchers, and
5	transportation services.
6	(6) Policies on planning projects specifically de-
7	signed to minimize potentially adverse impacts on
8	the environment and local communities.
9	(7) Policies on planning to mitigate climate
10	change or environmental justice concerns.
11	(8) Policies on sustaining existing or estab-
12	lishing new project labor agreements.
13	(9) Policies on consultation with local labor or-
14	ganizations.
